The Community Transport Brokerage provides a 'one stop shop' for community groups needing transport, enabling you to hire minibuses at low cost from other organisations. The service is free to members of BRCC.

- Drivers must have successfully completed a Minibus Driver Awareness Scheme (MiDAS) assessment
- All vehicles are subject to a quality standard to ensure that they are safe, legal and meet passengers' requirements
- All members must apply for a Section 19 Small Bus Permit, if they do not already have one

Accessible & easy to use

- A range of vehicles are available, some of which are equipped with passenger lifts or ramps
- Groups without their own trained driver have access to a network of MiDAS qualified drivers
- We advise on minibus use and volunteer driver MiDAS assessments
